### NON-RESIDENT Elector Response Form

(Kamloops property owner, who does NOT reside in the Kamloops municipal boundaries)

**I am OPPOSED** to the City of Kamloops proceeding with adopting *Tranquille Phase III Loan Authorization Bylaw No. 57-5, 2025*, authorizing borrowing \$9,000,000 to be repaid over a period not exceeding thirty (30) years, to finance the design, construction, and commissioning of Phase III of the Tranquille Road Sanitary Main and Road Enhancement Project, described on Page 3 of this form.

To sign an alternative approval process elector response form, you **MUST MEET ALL** the following criteria for a Non-Resident Elector:

I, the undersigned, hereby certify that:

- ▶ I am 18 years of age or older, and
- ▶ I am a Canadian citizen, and
- ▶ I have resided in British Columbia for at least six (6) months, and
- ▶ I am a non-resident property elector who resides outside Kamloops municipal boundaries and have been the registered owner of real property within the municipal boundaries of the City of Kamloops for at least thirty (30) days, and
- ▶ I am the sole registered owner of the real property, or I hold it with joint tenants or tenants in common, all of whom are individuals who do not hold the property in trust for a corporation or another trust; and
- ▶ I am the only individual claiming non-resident elector status with respect to the real property; and
- ▶ If I am the registered owner of the real property with other individuals, I have the written consent of the majority of the other property owners on the title to oppose this Bylaw; and
- ▶ I am not disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections, and
- ▶ I am entitled to sign this alternative approval process elector response form and have not previously signed an alternative approval process elector response form for this proposed Bylaw.

### NON-RESIDENT Elector Response Form

- ▶ A person must not sign an alternative approval process elector response form more than once and may not withdraw their name from the alternative approval process elector response form after the deadline for submission of the forms has passed.
- ▶ Personal information is collected to conduct the alternative approval process under the *Community Charter*. It will only be used by Legislative Services staff to verify the validity of the alternative approval process elector response forms, in accordance with [Council Policy No. GGL-33, Alternative Approval Process \(AAP\)](#). The City collects this information under sections 26(a) and (c) of the *Freedom of Information and Protection of Privacy Act*. #### Instructions:

- If you are **NOT OPPOSED** to the City borrowing nine million dollars (\$9,000,000) for Phase III of the Tranquille Road Sanitary Main and Road Enhancement Project outlined below, **you do not need to do anything.**
- If you are **OPPOSED** to the City borrowing nine million dollars (\$9,000,000) for Phase III of the Tranquille Road Sanitary Main and Road Enhancement Project outlined below, and you qualify as an elector of the City of Kamloops, you may sign an alternative approval process elector response form.
- Exact copies of the alternative approval process elector response forms may be made. This page of instructions is not considered part of the elector response form and does not need to be submitted with an accurate copy of the form.
- Each response form, or accurate copy, may be signed by one or more property owners; however, a submitted form is considered a single submission regardless of how many property owners have signed.
- If a corporation owns the property in part or in whole, NO elector response form may be submitted.
- There is **NO Corporate vote.**
- The City's Corporate Officer must receive all alternative approval process elector response forms by **4:00 pm on May 29, 2026** (postmarks are not accepted).
- Completed forms may be returned by:
  - mailing them to City of Kamloops 7 Victoria Street West, Kamloops, BC, V2C 1A2, Attention: Corporate Officer (postmarks not accepted);
  - delivering them in person at City Hall, 7 Victoria Street West, during regular business hours (Monday to Friday between 8:00 am and 4:00 pm, excluding statutory holidays);
  - depositing them into the 24-hour secure drop box at the entrance of City Hall; or
  - emailing a legible copy to [KamloopsAAP@kamloops.ca](mailto:KamloopsAAP@kamloops.ca).

#### What is Phase III of the Tranquille Road Sanitary Main and Road Enhancement Project?

This is the third and final phase of a project to replace the sanitary sewer trunk main that runs between Aviation Way and 12th Street. This main services approximately 39,000 people and is one of the city's most critical sewer mains. The infrastructure is nearing the end of its life and requires replacement and increased capacity to support growth.

In addition to the underground infrastructure, this project also includes several surface-level improvements, including a 1.5 m wide concrete sidewalk the north side of Tranquille Road and a 3.0 m wide multi-use pathway on the south side that will connect Fulton Field Park to the existing multi-use path that currently ends near Southill Street. This connection will complete an integral east-west bike corridor identified in the City's Transportation Master Plan. The project also includes drainage catch basins, storm drainage infiltration access points, trees, bus pullouts, water system upgrades, lighting, and other related improvements.
