Winter is Coming...

And so is the snow! Be prepared for snow this winter by removing obstructions from the road that inhibit the plows from being able to do their job - such as parked cars and basketball hoops.

Some other helpful tips for snow clearing:

- Do not push the snow from your driveway onto the road as this creates a hazardous situation for passing motorists, and when the snowplow does come around, the extra snow is going to end up in front of your driveway again.
- Pile snow on your property. If you shovel snow closer to your house at the beginning of the season, it will allow for more snow storage later on as snow piles grow.
- · Shovel snow to the right of your driveway to minimize your windrow size.
- · On garbage collection day, provide a clear path to your refuse container.

Community Climate Action Plan

Climate change is a global problem that is causing observable local impacts such as extreme-weather events, wildfires, flooding, and drought. The City is developing a Community Climate Action Plan (CCAP) to reduce greenhouse gas emissions in support of international efforts to limit global warming to 1.5 degrees Celsius. Policy options for 8 "Big Moves" were presented and open to feedback from the public and stakeholders in September and October. Zoning Bylaw Review and Update

The City is updating its existing Zoning Bylaw No. 5-1-2001, which regulates the use of land within city limits. The purpose of the update is to ensure that the zoning regulations are more clear, user-friendly, and business-friendly than the existing bylaw. The City sought feedback from the public and stakeholders on a draft Zoning Bylaw in October and November, and a revised Zoning Bylaw is expected to be adopted by early 2021. CityMap Just Got Better!

The City of Kamloops has recently launched CityMap (Kamloops.ca/CityMap), the City's public property-focused online map, with a new, more streamlined interface and added functionality. Users will find in-app links to related interactive maps, connecting even more data in one convenient location. The new interface should make it even easier to access and use the City's property reports.

The City's online maps are regularly used by residents including local businesses owners. Chris Ponti, who has been a residential appraiser in Kamloops for over 18 years, has been using CityMap in his job since it launched in 2015. It gives him the ability to understand a great deal about a property and its comparables before ever leaving the office.



"The layering system on the map is fabulous," said Ponti. "One of the main reasons we use CityMap is to access zoning information. Each property report links directly to its respective section of the Zoning Bylaw so we can quickly learn a lot, for example whether or not it is zoned for a potential legal suite."

Ray Visser, a local landscape architect, uses CityMap to evaluate the history of a site and to obtain information about utility services, existing easements, and slopes that might be on the property

in order to develop a preliminary landscape design.

"We've been depending on CityMap for so long now, I couldn't imagine not having it," said Visser. "Our processes would certainly be a lot slower if it didn't exist."
