

2020 Property Tax Deadline and Penalties

A friendly reminder that 2020 property taxes and Home Owner Grant applications were due on July 2, 2020. A 5% penalty was applied on July 31, 2020, to all unpaid residential property tax balances (Classes 1, 2, 3, and 9). Please pay by September 30, 2020, to avoid penalty or further penalty. On October 1, 2020, an additional 5% penalty will be applied to all unpaid residential property tax balances and a 10% penalty will be applied to all unpaid commercial property tax balances (Classes 4, 5, 6, 7, and 8) and unclaimed Home Owner Grants. 2021 City Calendar Call For Photos

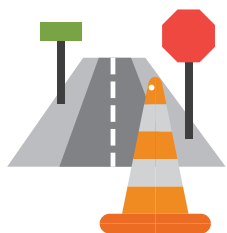

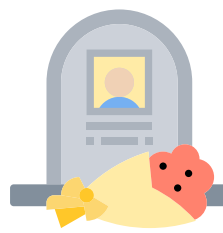
Attention Commuters!

Cemetery Master Plan and Bylaw Update

The City of Kamloops is looking to update its Cemetery Master Plan. Residential Suites Guide

To make it easier for homeowners to build legal and safe residential suites, the City has updated its Zoning Bylaw to allow secondary suites and garden suites in more urban areas. The new Guide to Residential Suites includes information on types of suites, where they are permitted, zoning and parking regulations, the process to build a new suite or to legalize an existing one, and answers to commonly asked questions. Fee Setting Bylaw No. 44-1

On May 5, 2020, Council authorized an amendment to Fees Setting Bylaw No. 44-1 to waive the following fees related to collection of property tax and utility fee revenue until December 31, 2020:

- non-sufficient funds (NSF) charges
- account transfer and refund charges
- additional tax notice or utility bill

In addition to the above, interest will be waived on overdue utility bills until December 31, 2020.

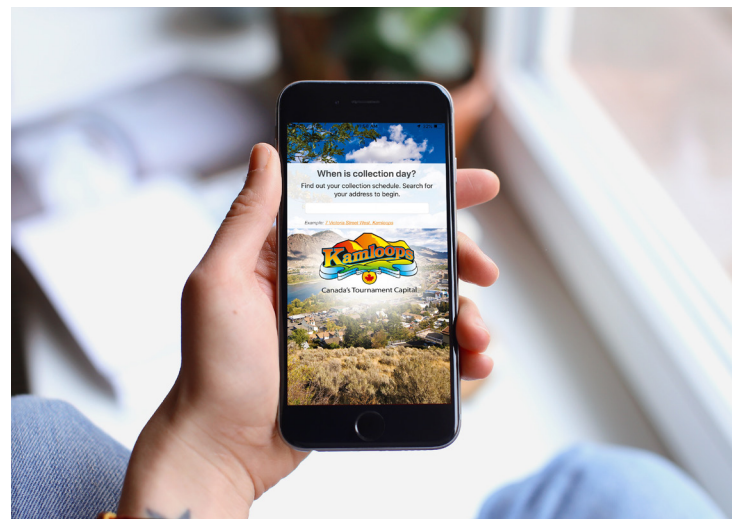
